Notice Inviting Tenders for providing support services in the recruitment process

Suitable service providers/agencies/consultants having proven track record of providing such services to Government / Private organizations and having a minimum turnover of Rs. 3 Crores during the last three financial years are invited to participate in the tender .

The service provider/agency should have minimum 5 years of experience in recruitment of technical persons in the Power Sector of the Government or its nodal bodies including Undertaking (Central PSU / State PSU) or Joint Venture of any government agency.

The service provider/agency who shall provide such services should not have any pending litigation in any court of law including Arbitration proceeding at the time of submission of tender with regard to any of its recruitment process.

The prospective bidder should satisfy themselves about their eligibility before submission of the offer. Bidder shall submit the tenders in the prescribed format strictly in accordance with the terms and conditions.
