- 2. The tenderers should submit the up to date (Bankers certificate) for financial soundness.
- 3. The tenderer should have to submit documents regarding successful completion within last three years of any of the following.
 - (a) Three similar completed works costing not less than the amount equal to 40% of the estimated cost each. OR
 - (b) Two similar completed works costing not less than the amount equal to 50% of the estimated cost each. OR
 - (c) One similar completed work costing not less than the amount equal to 80% of the estimated cost each.
- 4. The tenderer should have to produce the required documents of qualifying requirement such as valid labour license, income tax, Pan No. TIN No., Sale tax/Vat clearance certificate, up to date character certificate issue by D.C. /S.P. within one year and list of T&P and an affidavit for declaration by tenderer that their close members, blood relation/proxies are not employed in any office of the Jharkhand Bijali Vitran Nigam Ltd. & its constituent companies, at the time of request for purchase of B.O.Q. All certificate must be valid along-with others terms and condition of contract as on the date of opening of part-I of the tender.
